

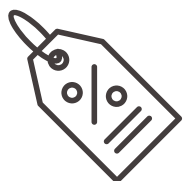

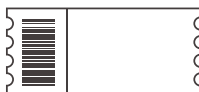

# Membership Policy

## 1. Purpose of the Policy

This policy aims to establish the conditions and benefits of MUMAQ's corporate membership program, designed for companies wishing to support our institution while offering cultural benefits to their employees.

## B. Objectives for Companies

- Engage with the local cultural offering and support a nearby organization
- Provide employees with social activities and opportunities for cultural discovery close to the workplace
- Offer networking opportunities
- Enhance promotional visibility
- Foster a philanthropic culture within the company to stand out among employees, peers, and competitors.

## 2 - Eligibility

The corporate membership program is open to companies of all sizes that wish to support our museum and its mission. Admission may be denied if a company's mission does not align with the values upheld by the museum.

## 3- Representation at AGMs and Voting Rights

The corporate member is considered an associate member. Upon registration, the company may designate a representative as an active member of the museum, who will have the right to attend Annual General Meetings (AGMs) and vote. The representative may be replaced at any time by submitting a letter of credentials for the new designation.

## 4 – Duration and Renewal

Corporate membership is valid for a period of one year from the date of enrollment. The member company will receive a renewal invoice payable within 30 days to maintain its membership.

## 5 – General Conditions

A. Membership benefits may not be transferred to third parties who are not employees of the member company, except for accompanying guest passes, which must be presented at the entrance.

B. The museum reserves the right to modify the benefits and conditions of the membership program at any time, with reasonable notice to members.

## 6 – Termination

The museum reserves the right to terminate a corporate membership in the event of non-compliance with the conditions of this policy or for any other reason deemed valid by management or the board of directors. In such cases, the museum will issue a prorated refund based on the number of months elapsed in the membership year.
